## SDOT THIRD AVE CHANGES

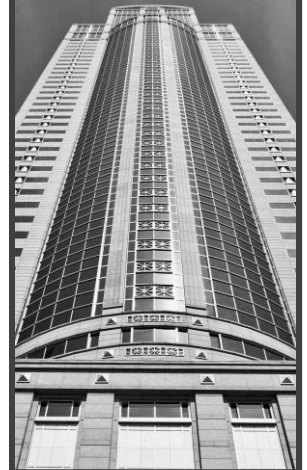
The Seattle Department of Transportation's new changes to the Third Avenue traffic began Monday, August 20.

The breakdown of the change is below, as well as available on <http://sdotblog.seattle.gov/2018/08/15/coming-soon-3rd-ave-transit-improvements/>

As of Monday, August 20th Third Ave from Stewart Street to just south of Yesler Way was reserved for buses and bicycles, from 6:00 a.m. – 7:00 p.m. seven days a week

- Cars are allowed on Third Avenue, from 7:00 p.m. to 6:00 a.m. seven days a week.
- No left turns off Third Avenue, 24/7
- You can cross Third Avenue going east-west, 24/7
- Permitted commercial vehicles are allowed to use Third Avenue from 9:00 a.m. – 3:00 p.m. and 7:00 p.m. – 6:00 a.m. seven days a week.
- One block rule still allows vehicles to turn right onto Third Avenue from University Street, travel in the right lane for one block and turn right off of Third Avenue to Seneca Street, in order to facilitate drop offs on Third Avenue or reaching the Seneca Street parking garage entrance.

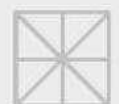
